## EMERGING THERAPIES COMMITTEE

The ISSVD Emerging Therapies Committee is committed to the continuous identification, critical appraisal, and synthesis of high-quality evidence on novel therapeutic approaches and technological innovations in the field of vulvovaginal health. The committee's scope encompasses systematic horizon scanning, research, cost-effectiveness and health technology assessments, and the integration of digital health and artificial intelligence. The committee will develop and disseminate position statements, consensus reports, guidelines, and educational resources to support evidence-based practice, guide clinical decisions, and advance the ISSVD's mission of global leadership in women's health.

### **Objectives:**

- **1.** Conduct ongoing surveillance and critical review of emerging pharmacological treatments and device-based interventions for vulvovaginal conditions.
- 2. Evaluate the translational feasibility, safety, efficacy, and cost-effectiveness of innovative therapeutic modalities, including regenerative approaches and energy-based technologies.
- **3.** Monitor novel therapies and conduct health outcomes research to inform evidencebased recommendations and identify gaps in clinical practice.
- **4.** Assess the role and impact of digital health tools and artificial intelligence in improving diagnostic accuracy, treatment personalization, and patient engagement.
- **5.** Develop, update, and disseminate position statements, consensus reports, and clinical guidelines consistent with ISSVD standards.
- 6. Produce peer-reviewed publications and educational materials to enhance awareness and adoption of emerging therapies among clinicians and patient communities.

#### **Deliverables:**

- Quarterly activity reports to the ISSVD Board detailing evidence updates, emerging trends, and priority topics.
- Annual evidence review of manuscripts for publication under ISSVD authorship.
- Position statements and cost-effectiveness briefs on high-priority therapies.
- Educational materials for clinicians and patients highlighting state-of-the-art treatment options and technological advances.

#### **Expected Impact:**

By maintaining a forward-looking and methodologically rigorous approach, the Emerging Therapies Committee will ensure that the ISSVD remains at the forefront of scientific innovation and clinical excellence in vulvovaginal disease management.
